



Education loans distributed to 435 students in Mannargudi

Tiruvavur, Oct 30: At a special education loan camp held at Rajagopalaswamy Government Arts and Science College in Mannargudi, Tiruvavur Collector V. Mohanachandran distributed bank drafts worth Rs 7 crore to 435 college students.

The camp was jointly organised by the district administration and the lead bank, Indian Overseas Bank, with the participation of all public sector banks in the district.

Speaking on the occasion, the Collector said the Tamil Nadu government has been implementing several schemes for the welfare of students and facilitating easy access to education loans.

Awareness camps are being conducted across all districts through lead banks to help college students understand the process of applying for loans. Banks have also been instructed to train students on using the Vidyalakshmi portal for loan applications.

He added that Tiruvavur district had achieved 100 per cent of the previous year's target in education loan disbursement, and this year's efforts would aim to replicate the same success. To make the process simpler, all necessary formalities for availing loans have been consolidated at a single venue, enabling students to receive proper guidance.

Indian Bank, State Bank of India, Canara Bank, and Bank of Baroda participated in the event and created awareness about education loans among students.

Rajagopalaswamy Government Arts and Science College Principal, Renganathaprabhu, government officials, bank managers, and students took part in the programme.



Collector flags off rainwater harvesting awareness rally

Virudhunagar, Oct 30: A rainwater harvesting awareness rally, organised by the Tamil Nadu Water Supply and Drainage Board (TWAD), was flagged off by Virudhunagar District Collector N.O. Sukhaputra, IAS, at the Desabandhu Ground on Wednesday.

Speaking on the occasion, the Collector said that as per the directives of the Tamil Nadu Government, rainwater harvesting awareness drives are conducted every year

ahead of the northeast monsoon to highlight the importance of conserving rainwater. Storing rainwater helps recharge groundwater levels and can significantly reduce water scarcity during summer months, she added.

She also explained that rainwater collected from rooftops in houses, schools, offices, shops and colleges can be channelled through filter tanks for storage, while in rural areas, wells and cleaned ponds can be

used effectively for water collection.

The Collector further advised the public to drink only boiled water to prevent waterborne diseases such as cholera, fever, diarrhoea, stomach pain, cough, and vomiting. She also urged residents to clear old tyres, coconut shells, and discarded bottles from their surroundings to prevent water stagnation.

After her address, the Collector distributed pamphlets on rainwater harvesting to the public

to create awareness.

The rally, which began near the Mariyamman Temple, passed through the main streets and the old bus stand area, with participants carrying placards promoting water conservation.

Officials from the TWAD Board, including Executive Engineer Karpagam, Assistant Executive Engineers, junior water analysts, school students, government staff, and members of the public took part in the event.
